- 1. The meeting was called to order at 5:07
- 2. The Pledge of Allegiance was recited.

- 5. The consent agenda and minutes of November 12, 2015 were approved unanimously.
- 6. Moved by Susie Kimble and seconded by Toby Rue that the existing officers viz. President-John Munoz, Vice-President- Susie Kimble, Treasurer Jennifer Garcia Kozlowski and Secretary- Martha Valdez, continue for 2016. Votes: Unanimous.
- 7. Moved by Susie Kimble and seconded by Toby Rue that Susie Kimble and John Munoz continue as director and alternate to the National Board. Votes: Unanimous.
- 8. Craig Cook presented the financial report. There was not much to report on for the reports ending 11/30/15. Operational revenue came in as normal and revenue from the reimbursement funds have finally started flowing from the PED. The expenditure report held no surprises and the BARs that are to be voted on are intended to eliminate all line items in deficit that have been discussed in detail in previous meetings of the finance committee and GC. The school had slightly more expenditures than revenues for the month of November with \$191k and expenditures of \$204k. The bank statement reconciled to the GL with \$881,524.71 in the main account and \$3,139.31 in the activity account. There are 4 BARs (#0007 through #0010) presented for approval. The first 2 BARs are for regular maintenance on the Operational fund. The 3rd BAR is to match the projected carryover to the actual carryover as derived from the draft financial statements as provided with the completion of the FY15 audit. The amount was an increase of \$157k. The final BAR is to increase the projection of E-Rate revenue to the actual revenues which

- resulted in an increase of about \$5k. All BARs were used to cover negative line items throughout the Operational budget. Moved by Susie Kimble and seconded by Martha Valdez that all BARs as presented be approved. Votes: Unanimous.
- 9. The dashboard presented a comparison for the last two years in areas of average number of students enrolled, number of students withdrawn and average number of students attending on a daily basis for the first 65 days for each year.
