- 5. The meeting was called to order at 5:35.
- 6. The consent agenda and minutes of September 10, 2015 were approved.
- 7. Craig Cook began the presentation of the financial reports by stating that the finance committee was unable to meet in full as some members were unable to make it. He stated that he, Mike Vigil II and Veronica Gonzalez met to go over the reports in detail and specifically to determine if any over expended budget lines warranted further discussion. It was determined that all lines over budget were for good purpose and could be covered by the increase that is projected with the growth from enrollment estimates. Mike Vigil II briefly went over the other reports. He noted that the only revenues to come in were from normal monthly distributions of SEG and HB-33 allocations. He also noted that expenditures exceeded revenues for the month of September which resulted in the cash in the bank being about \$100k lower than it was in the previous month. He anticipated that

this cash would be recouped in October with the receipt of PSCOC lease reimbursement funds for the 1st Quarter along with federal fund reimbursements that had been requested in September. Mr. Cook wrapped up the financial reports by stating that the bank reconciled to the GL with no variances. BAR #0006-IB was presented for the Dual Credit Instructional Materials fund in the amount of \$789. Moved by Susie Kimble and seconded by Jennifer Garcia Kozlowski that BAR 0006-IB be approved. Votes: Unanimous.

- 8. The principal presented data on MAP fall scores. The second taking of the MAP tests will be in January and the third in the spring. Our student growth from the baseline data will be compared to determine whether students have met their growth targets.
