Minutes of the GC

- 1. The Pledge of Allegiance was recited.
- 2. The mission statement was read by Susie Kimble.
- 3. Public input: Christy Jo Serna, Marcus Escobar, Rocio Reyes, Mariana Aldavaz, Natasha Medina. The staff members introduced themselves. Susie talked briefly about their role and an openness to listen to concerns or thoughts.
- 4. Quorum was reached at 5:23 pm.
- 5. Moved by Roberta Stathis seconded by Oscar Juarez that the agenda be accepted as presented. Votes: Unanimous.
- 6. Moved by Roberta Stathis seconded by Oscar Juarez that the minutes for the general meeting on July 14, 2022 be approved as presented. Votes: Unanimous
- 7. Ashley presented the budget reports covering the school until 6/30/2022 and 7/31/2022 BARs 0048-I, 0049-I, 0050-M, 0051-I, and 0052-T for FY22 and BARs 0001-I, 0002-IB, and 0003-IB to the finance committee. The finance committee had already reviewed the reports prior to the general board meeting to identify any irregularities. Superintendent's Report

School

- As of 8/5/2022, there are 163 students enrolled. 58 attend in the evening. We have X24Special Ed students enrolled.
- Our first "Fun Friday" will be on 8/12. Our plans are to be on campus in the morning working on academic skills then taking the students swimming in the afternoon. Students who have to complete assignments due to absences will need to stay behind to complete the work.
- Parent Conferences are on the 19th.

- On 8/4/22, I met with LCPS's CTE program director and LCHBA president, Nichole Black at OMHS. We toured the house students are building. We also discussed a collaboration between both schools. My next step is to speak to Superintendent Ramos about moving forward with a possible plan to integrate our students.
