- 5. Moved by Martha Valdez and seconded by Roberta Stathis that the agenda be accepted with the proposed changes of moving item #4 to 2<sup>nd</sup> place and removing #6 completely. Votes: Unanimous.
- 6. Moved by Roberta Stathis and seconded by Martha Valdez that Julia Rivera-Tapia be accepted as a member of the Governing Council. Votes: Unanimous
- 7. Moved by Roberta Stathis seconded by Martha Valdez that the minutes from October 13, 2022 be approved as presented. Votes: Unanimous
