Minutes of the GC

- 1. The Pledge of Allegiance was recited.
- 2. The mission statement was read by Susie Kimble.
- 3. Public input: Coach Esparza expressed his gratitude toward administration for their support of the basketball season.
- 4. Quorum was reached at 5:27 pm.
- 5. Motion to approve the agenda with the date correction. Moved by Roberta Stathis and seconded by Julia Rivera-Tapia that the agenda be accepted as presented with the edit. Votes: Unanimous.
- 6. Moved by Roberta Stathis and seconded by Jesus Lozoya that the minutes of April 27, 2023, be accepted as presented. Votes: unanimous.
- 7. Ashley presented the budget reports covering the school until 4/30/2023 BARs 43-I, 44-I,45-I, 46-D,47-I, 48-T, 49-T,50-T, 51-T, 52-T,53-T,54-T, 55-M, 60-I were approved by the finance committee. The finance committee had already reviewed the reports prior to the general board meeting to identify any

- irregularities. Moved by Jesus Lozoya and seconded by Julia Rivera-Tapia that the financial reports and BARs for March and April be accepted as presented. Votes: Unanimous.
