Minutes of the GC

- 1. The Pledge of Allegiance was recited.
- 2. The mission statement was read by Susie Kimble.
- 3. Quorum was reached at 5:00 pm.
- 4. One revision was made to the agenda.
- 5. Moved by Roberta Stathis and seconded by Jessica Castro-Buelna that the agenda be accepted as presented. Votes: Unanimous.
- 6. Motion to approve the minutes of December 14 with one revision. Moved by Jesus Lozoya and seconded by Jessica Castro-Buelna that the minutes be accepted as amended. Votes: unanimous.
- 7. Ashley presented the budget reports covering the school until December 31, 2023.
